Pursuant to Texas Rule of Civil Procedure 162, Plaintiff hereby nonsuits, without prejudice, the following specific claims for relief asserted in Plaintiff's Original Petition:

1. All claims for the removal of Randy Schackmann, Kim Brady, Cassandra Hatfield, Ileana Garza-Rojas, and Marjorie Barnes from the CFBISD Board of Trustees pursuant to Chapter 87 of the Texas Local Government Code.
2. All claims for the removal of Wendy Eldredge from her position as superintendent of CFBISD and the related request to declare her contract null and void.
3. All claims for the repayment to the District of public funds received by prohibited individuals in violation of Chapter 573 of the Texas Government Code.
